RE: CEO Report

- 1. Clinic Operations:
 - Due to Covid-19 protocols, there were cancelled patient appointments due to staff being out of the office.
 - June had 1,175 visits, 104 visits less than budget. FY22's visit volume will be reported with the end of the fiscal year financials and August CEO report.
- 2. FQHC and Farmworkers Contract:
 - The SMMC FQHC contract will go before the San Mateo County Board of Supervisors on August 2nd. The three-year contract renewal is for \$1,000,000 and includes a 6.9% rate increase in the per visit rate, from \$290 to \$310/visit.
- **3.** Financial Update:
 - May Financial Reports:
 - i. May financial reports will be provided to the board during the August board meeting. The HPSM Dental Integration Pilot, outsourcing of insurance billing, the resignation of long tenured employees and workflow changes has required a review of open insurance claims to ensure that Accounts Receivable Revenue is accurately reported.
 - ii. The Board Chair, CFO and CEO made the decision to delay May financial reports.
 - On July 22nd, Sonrisas' current cash position was \$1,652,000.

In June 2022, the Development team completed our Fiscal Year-End fundraising campaign; began intensive preparation for Sonrisas' 2022 Cooking for a Cause; and submitted several major grant proposals.

As of June 30, 2022, we raised \$1,829,452 (108%) of our \$1,690,000 FY21-22 fundraising goal (includes PHCD support). Please see the attached Fundraising Report for visual overview.

1. Individual Donations

- As of June 30, 2022, we received \$126,727 in individual donations and sponsorships in FY21-22.
- Our *Healthy Smiles Plant the Seeds for Healthy Lives* first-ever Fiscal Year End fundraising campaign raised \$7,720.23. Thank you to those of you who donated!

2. Grant Seeking

- Sonrisas was awarded \$781,597 in grants as of June 30, 2022, exceeding our annual grant award target for FY21-22. We are currently in consideration for \$244,000 in grant funding with decisions expected in FY22-23.
- New areas in which we seek funding include workforce equity and Dental Assistant pipeline programming.


- Ticket sales are now live for Sonrisas' 8th Annual Cooking for a Cause: Visions of Valencia to be held Saturday, September 17th, 2022.



RE: Community Engagement Director Report – July 2022

Summer has been an exciting season for Sonrisas' Older Adult Community Programs! Due to the collaborative efforts of Sonrisas' development, community, and clinical teams, Sonrisas Dental Health has been awarded \$100,000 by Delta Dental Community Care Foundation to continue our development and implementation of both community-based and clinical Access to Care programs in FY22-23. This second year of funding will enable Sonrisas to provide the following services to people 65 and older to help improve their access to dental care:

• Community Screenings for seniors

• Using portable equipment, Sonrisas' Community Outreach team will provide dental assessments and customized oral health maintenance recommendations onsite at assisted living facilities, senior day centers, low-income senior housing facilities, etc.

• Aging Adult Care Coordinator (AACC)

- A Care Coordinator focused specifically on serving aging and older adults will assist senior patients (new and existing) with filling out paperwork, scheduling appointments, arranging transportation, and acting as a dedicated point of contact
- Senior ATC visit goal
 - Funding for uncompensated care of 154 clinical visits for 40 seniors in FY22-23
- Senior Oral Health Care Internal Task Force
 - o Community and Clinical Team members will meet monthly to discuss senior patients' urgency of treatment needs and clinical capacity
- Senior Care Advisory Team
 - Community members from our Year 1 Advisory Board will continue to serve as a source of information and inspiration (these members include community members aged 65 and older, caregivers, and health care providers and administrators who serve older adults)
- Geriatric Dental Expert Consultation
 - On-call consultation from Dr. Peter Kawamura (geriatric specialist) to review complex patient treatment needs and advise Sonrisas clinicians
 - o Guidance from Dr. Kawamura on community-based dental services
- Staff in-service trainings
 - Trainings about specific needs of older adults in accessing dental care, including concerns like treating patients with memory loss and common health conditions faced by seniors
- Transportation funding
 - For patients who do not have access to transportation, the AACC can use funding from this grant to help patients get to Sonrisas Centers

With financial support from the ongoing first year of funding from Delta, SDH has been providing oral health education presentations and mobile dental visits (x-rays and dental cleanings) for patients in facilities throughout Burlingame, Menlo Park, Millbrae, San Mateo, and Redwood City. Special thanks to staff and administrators of Self Help for the Elderly, Peninsula Family Service, Crane Place Senior Housing, PVI Little House, Coastside Hope, and Senior Coastsiders for helping Sonrisas coordinate this care for their participants.
